

ADMISSION POLICY FOR NURSING PROGRAMS AT REHMAN COLLEGE OF NURSING FOR THE SESSION 2024-25

The following Admission Policy is formulated to comply with the requirements of affiliating Universities & regulatory bodies:

A. Eligibility criteria

Any person seeking admission to RMI Nursing programs shall be eligible haigfulfilled the following mandatory criteria:

For Bachelor of Science in Nursing (BSN)

- Premedical or equivalent with minimum 50% marks
- The maximum age limit is up to 30 years

For Post RN BScN

- 3 years Diploma in Nursing (RN)
- 1-year Diploma in Midwifery / any post-basic specialty
- Both male and female
- Valid PNC License

For the Certified Nursing Assistant Program (CNA)

- Matric (Science) with minimum 50% marks
- Age: 17 30 years
- Gender: Both male and female
- Science group candidates will be preferred

B. Merit Weightage

For BSN Program

HSSC or equivalent: 50% KMU-CAT: 40% Interview: 10%

For Post RN BScN Program

Entry test: 100%

For CNA Program

Entry Test: 80% Interview: 20%

C. Merit list

- 1. The admission to above nursing programs shall be made strictly based on merit.
- 2. In case the final merit of more than one candidate is equal to up to four decimals, the candidate older in age shall stand higher in merit.



3. After the display of the final merit list, if there is any vacant seat, the next student on meritin the waiting list will be offered admission against such vacant seat.

D. Admission process

- 1. The applications through the online portal of the college shall be accepted for scrutinyand merit formulation.
- 2. It will be the responsibility of the candidate to provide all academic & personal documents as required by the college prior to the last date of admissions as specified on the website.
- **3.** Communication with the applicants will be strictly through the email address provided by the applicants.
- **4.** Visiting the college website for day-to-day updates will be the responsibility of the applicants.
- 5. Selected applicants and their parents/guardians will be required to submit an affidavit on an Rs. 100/- stamp paper duly notarized by a notary, stating the acceptance of College required disciplinary, legal, and financial responsibilities and all other rules andregulations specified in the college prospectus.
- **6.** Admission will remain conditional subject to verification of all documents, and passing medical fitness test.
- 7. Personal appearance for verification of documents and interview is mandatory.
- **8.** Admission offer will be valid only on fee deposit within the stipulated period given below.

E. Payment of College Fee

The selected applicants shall be bound to deposit the fee within three working days, failing which the admission offer shall automatically stand withdrawn and the next candidate on merit will be issued an admission offer.

F. General Provisions

- a. Regulatory Authorities' directives regarding admissions issued fromtime to time will be followed.
- b. A strict NO DONATION POLICY is adopted. No one, except the office of admissions, is authorized to give a written admission offer.
- c. Fee for more than one (1) Semester will not be demanded.
- d. All fees will be deposited in the official College designated bank account.
- e. SCHOLARSHIPS: As per institutions' past practices, scholarships will be offered as per policy notified from time to time.
